I would like to take this opportunity to thank Ros Clarke and Judy Flanagan who returned in July 2018 to act in the GM position whilst recruitment was underway, and who were both generous in their time during my induction period.

Staffing and human resources issues took up much time in the first half of 2019 and at times we have managed with positions vacant. I wish to thank staff and volunteers for pulling together during these times, particularly to Lynne Milligan and Lynda Hancy who stepped in to cover vacancies in events coordination and volunteering.

Despite a year marked by operational challenges, our re-homing rate increased from 1111 dogs in 2017/18 to 1208 dogs in 2018/19. Our intent is to surpass this figure in the 2019/20 financial year and to that end we have solidified relationships with external partners and some fantastic new associations have been formed.

We have continued the great relationships we have with Sue from Poundwatch and all the local pounds we service.

Strengthening our ties with the City of Greater Geraldton has resulted in more trips and more dogs saved from the Geraldton and Northampton area. We look forward to reporting a significant increase in intake from the Mid-West in 2019/20.

I feel blessed to have met Wendy Roberts who rescues and transports dogs to us from Broome and Halls Creek areas as an individual, nonorganisational affiliated wonder woman. Instrumental in forming a relationship with an airline that provides, on occasion, free dog flights from Broome to Perth has allowed us to further our dog intake numbers from the north region.

Likewise, Sally Dixon who has formed the foster based rescue group BARRC, Bunbury has become a close contact that we regularly assist and collaborate with to rehome dogs from Bunbury and surrounds.

I would like to take this opportunity to whole heartedly thank the staff for working with me towards a more united and cohesive team, doing it for the dogs; all of our amazing volunteers who give their hearts and souls and so much of their time dedicated to the Home and its dogs; the foster carers who give our dogs the opportunity for relief and more importantly the chance to shine and therefore be more adoptable; the Board for their support; and the WA public for continuing to show that they also believe that 'rescue is the best breed'.

Thank you to all who continue to make us the success we are at the Dogs' Refuge Home.

President's <u>Report</u>

Firstly, apologies for the lateness of this report but there is a good reason. We have been fortunate enough to partner with Grant Thornton, a large accounting and professional consultancy who offered to complete our independent audit pro bono this year saving us \$8,000.

This has resulted in slightly later financial statements, but as our member's know and appreciate – every dollar counts.

I would like to thank and acknowledge our new audit partner, Lorenzo Stella and his team at Grant Thornton, who have made this process very smooth and who have been extremely thorough.

Unfortunately, for the first time in many years, we haven't been able to show a surplus at the end of the reporting year. Whilst this is obviously a concern to the Board, it has illustrated more than ever (and something we have always known), without generous gifts left in Wills, we simply cannot self-fund our work or continue with a facilities upgrade program.

The financial support we receive from the community underpins everything we do and we are extremely grateful for it. The 2019/2020 year is off to a good start with a number of bequests received or in the pipeline. The drop in legacy revenue of some \$600,000 in 2018/19 when compared to 2017/18 has highlighted the need to invest further fundraising resources into securing gifts in wills along with increasing our general fundraising. We look forward to working on new initiatives in this area over the coming year.

Of course, when we do achieve a surplus it allows us to continue our re-build plan and last year was the first time in seven years we haven't been building a kennel or our new administration building. We look forward to seeing hard hats around the place again very soon.

Kristi Treadgold joined us as General Manager in December 2018 and hit the ground running. Dog intake and adoptions have increased since Kristi started and she has led our Dog Welfare Committee which meets regularly and is seeing increasingly good outcomes for our dogs. We welcome Kristi and are very excited about the increased number of dogs we have been able to save and



re-home and look forward to this continuing.

Our events throughout the year are always memorable and at our annual quiz night, celebrating our 10th year, we acknowledged Nelson Woss as one of our Patron's and artist Helen Norton as a Life Member.

Thanks and acknowledgement also to the incredibly generous Tate Family Foundation who once again provided \$25,000 in matched giving for our annual In the Doghouse fundraiser.

I want to also thank the amazing Board I work alongside. The hours they selflessly donate is understated and whether it be driving and managing an event to help raise funds, providing valuable legal advice and guidance, managing our finances and investments or driving our operations, they never waiver in their support of our Home and our dogs.

We have a few new partners who are also assisting with professional support and advice including Tanya Pavez and her team from Magnetic People and Rachel Dawson from Herbert Smith Freehills.

The volunteers (without whom we wouldn't exist) and the staff are the backbone of our organisation. We could never afford the labour cost to run such a large scale operation without our volunteers and to each and every one of you, I applaud and thank you for the countless hours you give to our dogs.

To everyone who has adopted from us, donated or helped us to raise awareness of our work, a heartfelt thank you.

I look forward to another amazing year – saving dogs from all over the State, building on the fabulous relationships we have with our stakeholders and improving the quality of the care we give our dogs until we find them a forever home.

Next year we celebrate our 85th anniversary – another milestone and another reason to be extremely proud of our operation and our people.


Governance & Financial Report

Financial Summary


The Dogs' Refuge Home is an independent not for profit run by a skilled volunteer Board in collaboration with a salaried General Manager. Our annual operating costs exceed \$2.5 million, and while we receive a small grant from the State Government, it represents only 3% of our revenue. During 2018/19 we were unable to breakeven for the first time in a number of years, despite increasing fundraising income by 10%. The primary reason for our shortfall was a significant drop in Legacy income from 34% of revenue in 2017/18 to just 12% in 2018/19. As a primarily self-funded organisation, this year highlighted just how important gifts in wills and donations are to the Home's ongoing sustainability.
